OFFICE MEMORANDUM

Subject: Ceiling Price fixation of remaining 102 NLEM formulations under provisions of DPCO, 2013.

In reference to the subject mentioned above, **all the concerned manufacturers/ marketing companies** are requested to furnish the Price to Retailer (PTR) and Moving Annual Turnover (MAT) in value terms for the months indicated in the enclosed Annexure-I (87 formulations for which May, 2012 data is required) and Annexure-II (15 common formulations listed in DPCO, 1995 also, for which Sep., 2013 data is required), **within 7 days positively** from the issue of this OM, for taking appropriate action for ceiling price fixation under Para 4/6 of DPCO, 2013.

2. Non-submission of the data/information will be viewed seriously. Therefore, the above-mentioned information may please be furnished within the stipulated period, **failing which appropriate action will be taken under provisions of DPCO, 2013 read with the E.C. Act, 1955 for non-compliance/furnishing of data/information.**
