Office Memorandum

This is in reference to the Office Memorandum dated 20.02.2018, 27.02.2018, 09.06.2021 in respect of medical devices namely (i) Bare Metal Stents (ii) Drug Eluting Stents (iii) Orthopaedic Knee Implants (iv) Oxygen Concentrators, respectively, wherein, manufacturers/importers were directed to submit monthly stock details. In this regard, representations were received from Industry associations that the companies may be allowed to submit quarterly stock details instead of monthly. The matter was deliberated in the Authority meeting held on 15.11.2021 and it was decided that the submission of information relating to stock details of aforesaid medical devices may be reported on quarterly basis instead of monthly. Henceforth, the companies are required to submit the stock details of these devices on quarterly basis in the prescribed format (enclosed) starting from quarter ended December 2021.
